¹ If sea marshals embarkation or disembarkation in Galle need not be arranged by AGMS, USD 1,500.00 will be deducted.

² Team embarkation/disembarkation in Suez. Weapons kit transfer at floating armoury in Red Sea. If sea marshals embarkation or disembarkation in Suez need not be arranged by AGMS, USD 1,000.00 will be deducted.

³ Team embarkation/disembarkation in Fujairah Anchorage. Weapons kit transfer at floating armoury in Gulf of Oman. USD 2,500.00 will be deducted if AGMS is not required to arrange embarkation or disembarkation of PMSC's and AGMS' sea marshals in Fujairah anchorage.

⁴ Disembarkation or Embarkation inside port at berth. Extra launch cost will apply if transfer takes place in OPL or anchorage.

- A) Above tariff includes embarkation/disembarkation costs, visa and immigration clearance of all sea marshals and transport (land/sea) from airport to vessel or vice versa.
- B) Team leaders and additional sea marshals can be provided at USD 3,000.00 and USD 2,500.00 respectively.
- C) Job cancellation fee of USD 500.00 is applicable if such cancellation is done after MOD approval (EUC) is issued.
- D) USD 400 will be deducted if Body Armours/Helmets set is not required by the client.
- E) All weapons and ammunition shall be handed over to AGMS officers or Agents in abovementioned Port cities or AGMS floating armouries within 30 days of embarkation. Surcharges are applicable if 30 days are exceeded.
- F) Sri Lankan sea marshal must accompany the weapons/ammunition until they are placed in safe custody in armouries.
- G) Hotel accommodation for all sea marshals will be arranged if required and invoiced on top of tariff amount at actual costs.
- H) Air tickets for Sri Lankan sea marshal(s) if required can be arranged by AGMS and invoiced at actual cost on top of tariff amount. However, PMSC has the liberty to provide the ticket for Sri Lankan sea marshal(s) if preferred.
